Information concerning the processing of personal data by the Medicover Foundation in connection with the FitSchool Programme  
(hereinafter: the Programme)

### 1. Your personal data controller

Your personal data will be controlled by the Medicover Foundation, al. Jerozolimskie 96, 00-807 Warsaw (hereinafter: we / us). You can contact us:

### 2. Data Protection Officer

We have appointed a Data Protection Officer (DPO). The DPO is the person you can contact with queries regarding all matters concerning the processing of your personal data and the exercise of your rights in relation to data processing. You can contact the DPO as follows:

### 3. Purposes and legal basis for processing your data

We will process your personal data for the following purposes:

- in the case where you are the partner school's / educational institution's Representative, to enable you to apply to join the Programme on behalf of your school / educational institution,
- to handle any complaints you may make,
- to carry out satisfaction surveys for the Programme's participants (including surveys based on profiling),
- to provide you with educational materials and materials that promote our initiatives and services.

The legal bases for processing your data are:

- your agreement to have your data processed,
- the binding legislation,
- the legitimate interests of the data controller, which are: promotion of our activities, pursuing our claims and defence against claims, delivery of satisfaction surveys for the Programme's participants (including profiling).

### 4. Information on profiling

On the basis of your personal data, we carry out profiling, i.e., an automated assessment of certain personal factors that concern yourself. The result of this assessment is referred to as profiling. We perform profiling in order to properly select communication and promotional materials concerning the controller's activities. We will select the matching content of our communication and promotional materials based on your profile. We use the following data for profiling: first name, last name, gender, locality, data source. In addition, when we implement profiling, we take into account statistical data on your behaviour on our websites.

### 5. Period of retention of your personal data

The data we process upon your consent will be processed until you revoke it, on the basis of the law and for the period specified in the law and, in the case of processing due to the legitimate interest of the data controller, until you file an effective objection against data retention.

### 6. Recipients of your personal data

We will transfer your personal data to:

- entities that process data in the course of their service provision for the Medicover Foundation (e.g., IT support services),
- entities authorised by law (e.g., courts),
- persons and entities you have authorised to receive the data (e.g., in the form of a power of attorney).

### 7. Your rights in relation to the processing of personal data

You have the following rights in relation to the processing of your personal data:

- a. the right to object to the processing on the grounds of your situation – in cases where we process your data on the basis of our legitimate interest,
- b. the right to withdraw your consent,
- c. the right to access your personal data,
- d. the right to request the rectification of your personal data,
- e. the right to request the deletion of your personal data, unless we are obliged by law to process it,
- f. the right to request the restriction of the processing of your personal data,
- g. the right to portability of your personal data,
- h. the right to object to the processing of data for marketing purposes.

Your right to file a complaint with an authority

You also have the right to lodge a complaint with the state authority responsible for personal data protection, i.e., the President of the Data Protection Authority.

### 8. Obligation to provide data

The provision of your personal data is voluntary but necessary in order for you, as a representative of your school / educational institution, to be able to apply to participate in the Programme on behalf of your school / educational institution.
